Follow-Up After Emergency Department Visit for People with Multiple High-Risk Chronic Conditions (FMC)



Measure Description

Adults 18 years of age and older who have multiple high-risk chronic conditions who had a follow-up service within seven days (eight total days) of an Emergency Department (ED) visit.

Notes

- Members must be 18 years of age or older as of the ED visit date
- The ED visit must occur on or between January 1, 2025, and December 24, 2025
- The following are eligible chronic condition diagnoses:
 - Acute Myocardial Infarction
 - Alzheimer's Disease and related disorders
 - Atrial Fibrillation
 - Chronic Kidney Disease
 - COPD, Asthma, or unspecified Bronchitis
 - Depression
 - Heart Failure
 - Stroke and Transient Ischemic Attack

Tips and Best Practices to Help Improve Performance

- Reach out to patients as soon as you are notified of their ED visit to schedule their follow-up visit. Follow-up care for people with mental health conditions can result in fewer repeat ED visits, as well as improved physical and mental function, and increased compliance with follow-up instructions.
- Receiving timely information from hospitals can assist in faster follow-up. Consider utilizing your Health Information Exchange (HIE) to gain more information on ED discharges or by working collaboratively with the ED to obtain data exchange reports on your patients to improve care coordination.
- Consider maintaining appointment availability in your calendar dedicated for patients with recent ED visits to ensure they can schedule follow-up appointments in a timely manner.
- Consider outreach to reschedule for patients that cancel appointments or do not show up.
- Refer patients to appropriate behavioral health providers in their area.
- Utilize the monthly Gaps in Care Report (GIC) for a list of MVP Members and the services they still need.
